

# LIGHTNING LOTTO GAME CONDITIONS AND PRIZE STRUCTURE STATEMENT

# 1.0 Rules and Regulations

1.1 LIGHTNING LOTTO is governed by the Rules and Regulations Respecting Lotteries and Gaming of Western Canada Lottery Corporation (WCLC) WHICH INCLUDE LIMITATIONS OF LIABILITY AND ARE AVAILABLE FROM WCLC UPON REQUEST.

# 2.0 Game Participation and Definitions

- 2.1 In LIGHTNING LOTTO:
  - a) "Growing Jackpot" means a prize pool for the 5/5 Winning Selection, as described in section 5.1. The Growing Jackpot begins at a base amount and increases with every LIGHTNING LOTTO wager until it is won, at which time the Growing Jackpot immediately re-sets to the base amount;
  - b) "Selection" means one set of five numbers from 1 to 49 inclusive.
- 2.2 A player may participate by Quick Pick only.
- 2.3 A player may request from one to five Quick Pick plays per ticket at a cost of \$3 per play.
- 2.4 Each Quick Pick play is comprised of three Selections.
- 2.5 For each ticket and play requested and paid for, the computer system will:
  - a) generate three Selections for each Quick Pick play;
  - b) display on the customer display screen of the retailer's terminal (when available):
    - i. a LIGHTNING LOTTO animated graphic; and
    - ii. a message that will indicate whether the ticket is a winner for the Lightning Lotto game;
  - c) issue a ticket that will display:
    - i. the three Selections for each Quick Pick play;
    - ii. the applicable draw date for which the ticket is eligible;
    - iii. the five main draw numbers and the one bonus number for that draw date;
    - iv. the dollar amount wagered;
    - v. a message that will indicate whether the ticket is a winner for the Lightning Lotto game; and
    - vi. other information pertinent to the game.
- 2.6 The computer system will not issue the same Selection more than once on a ticket.
- 2.7 Sales for each draw date begin and close as may be determined by WCLC.

### **3.0 Draw**

3.1 Prior to the beginning of sales for each draw date, WCLC will cause five main numbers and one bonus number (being six different numbers) to be drawn at random from among all numbers from 1 to 49. The six different numbers drawn for a draw date will be the "winning numbers" for the sales that commence after such draw and will continue to be the "winning numbers" until a new draw takes place.

## 4.0 Winning Selections

4.1 Winning Selections as a result of any draw are determined as follows:

Winning Selection	Consists of	
5/5	The five main numbers	
4/5 + Bonus	Any four main numbers and the bonus number	
4/5	Any four main numbers and one other number*	
3/5 + Bonus	Any three main numbers, the bonus number and one other number*	
3/5	Any three main numbers and two other numbers*	
2/5 + Bonus	Any two main numbers, the bonus number and two other numbers*	
2/5	Any two main numbers and three other numbers*	

<sup>\* &</sup>quot;other" number means any number which has not been drawn.

# 5.0 Winning Tickets and Prizes

5.1 Any valid ticket for any draw bearing any Winning Selection of such draw is a winning ticket and entitles its holder(s) to claim, for each such Winning Selection, a prize calculated in accordance with the following:

Winning Selection	Prize
5/5	100% of the Growing Jackpot (\$100,000 minimum) (1) (2)
4/5 + Bonus	\$5,000
4/5	\$200
3/5 + Bonus	\$50
3/5	\$10
2/5 + Bonus	\$10
2/5	\$3

- (1) The starting base amount of the Growing Jackpot is \$100,000. The Growing Jackpot increases by the dollar amount equal to 21.18 per cent of each LIGHTNING LOTTO ticket wager until the Growing Jackpot is won, at which time the Growing Jackpot immediately re-sets to the starting base amount of \$100,000 and begins to grow again with each subsequent wager. The precise Growing Jackpot amount at the time of issue of a winning ticket bearing a 5/5 Winning Selection is dependent on LIGHTNING LOTTO product sales at the time that winning ticket is issued.
- (2) If the Growing Jackpot is not won for a draw date, the amount of that Growing Jackpot will carry over to the next draw date and continue to grow with every ticket sold until it is won.

5.2 The amount of the Growing Jackpot advertised is estimated and for information purposes only, and may not be the same as the actual amount of the Growing Jackpot. In the event of a difference between the advertised amount of the estimated Growing Jackpot and the amount of the Growing Jackpot in the computer system, the information in the computer system will govern.

## 6.0 Cancellation of a Ticket

6.1 A ticket cannot be cancelled by a retailer.

### 7.0 Prize Claims

7.1 Prizes must be claimed within one year following the draw date printed on the ticket in the manner stated on the back of the ticket.

# 8.0 Odds of Winning

8.1 The approximate odds of winning in the draw per play are as follows:

Winning Selection	Odds of Winning
5/5	1 in 635,628
4/5 + Bonus	1 in 127,126
4/5	1 in 2,956
3/5 + Bonus	1 in 1,478
3/5	1 in 70.4
2/5 + Bonus	1 in 70.4
2 of 5	1 in 5.2

Any Prize 1 in 4.5

## 9.0 Miscellaneous

- 9.1 WCLC may amend these Game Conditions and Prize Structure Statement at any time, in any manner.
- 9.2 The headings in these Game Conditions and Prize Structure Statement are for convenience of reference only and do not affect the interpretation of these Game Conditions and Prize Structure Statement.
