

# Official Back To The Future Facebook and Instagram Contest Conditions

This Contest is being held by the Western Canada Lottery Corporation (“WCLC”) and will run and entries will be accepted from July 13, 2026, at 9:00 am MT to July 20, 2026, at 9:00 am MT (the “Contest Period”).

## Eligibility

1. This Contest is only open to individuals who are 18 years of age or older and a resident of Alberta, Saskatchewan, Manitoba, Yukon Territory, Northwest Territories or Nunavut and who are not a:
  - a) WCLC, Alberta Gaming, Liquor and Cannabis Commission (“AGLC”), Manitoba Liquor and Lotteries Corporation (“MBLL”), Saskatchewan Lotteries, Lotteries Yukon, NWT & Nunavut Lotteries, NWT Sport and Recreation Council, Sport North or Northwest Territories Lottery Commission director, officer or employee;
  - b) WCLC consultant or contractor or a director, officer or employee of a WCLC consultant or contractor;
  - c) WCLC lottery retailer or a director, officer or employee of a WCLC retailer; or
  - d) Immediate family or household member of any of the individuals referenced in (a), (b) or (c).

## How to Enter

2. No purchase is necessary to enter the Contest. To enter the Contest an eligible participant must during the Contest Period:
  - a) Go to <https://www.facebook.com/lottospot/> or <https://www.instagram.com/lottospot/> from a computer or mobile device located in Alberta, Saskatchewan, Manitoba, Yukon Territory, Northwest Territories or Nunavut;
  - b) Find the Contest entry post; and
  - c) Comment on the post by answering the following question:
    - i. If I could go back in time, I’d hit replay on \_\_\_\_.
3. An eligible participant can enter the Contest only once and more than one entry per individual will make ALL entries submitted by that individual invalid.

## Prizes and Draws

4. There are ten (10) Contest prizes to be awarded each consisting of a Back To The Future prize pack of a cap, a trilogy movie collection, three (3) 1:32 scale time machine car models and a pack of playing cards as selected by WCLC valued at approximately \$70 (each a “Prize”).
5. A draw to select ten (10) Contest entries (“Drawn Entrants”) from all eligible Contest entries will be conducted within 48 hours after the Contest Period ends or as soon as practicable thereafter by WCLC.
6. A number of alternate Contest entries will also be drawn. In the event that a Drawn Entrant is subsequently disqualified or otherwise determined to be ineligible for the Contest or doesn’t respond within the timeline provided, a Prize may be awarded to the first eligible alternate Contest drawn entrant, and so on.
7. The chance of being selected in a draw is dependent on the number of Contest entries received.
8. All draws will adhere to the draw procedures established for the draw by WCLC.

WCLC will list the Drawn Entrants and the alternative Contest drawn entrants in the comments of the Contest entry post within 72 hours of contest closing or as or as soon as practicable thereafter by WCLC. The listed Drawn Entrants and the alternate Contest drawn entrants will then need to DM Lotto Spot within 72 hours of the listing or they will be disqualified. A WCLC representative will respond with the next steps in the process. If a Drawn Entrant does not confirm their intent to accept a Prize within 48 hours after WCLC attempts to contact each of the Drawn Entrants, that Drawn Entrant will be disqualified and WCLC will attempt to contact the next available alternate drawn entrant.
10. Each participant whose Contest entry is selected must correctly answer, unaided, a mathematical skill-testing question in order to be declared a winner. Failure to do so will result in disqualification.

In order to receive a Prize, a winner must also provide WCLC with a completed and signed Acknowledgement and Release form and present government-issued photo identification verifying their name, age and residency, in the time period specified by WCLC. Though reasonable efforts will be made to correctly identify and contact winners, WCLC reserves the right to disqualify any selected participant on the basis that a Contest entry is ineligible, provided contact information is incorrect or invalid, a participant has entered the Contest more than once, or WCLC is otherwise unable to contact or locate a participant who is drawn for a Prize.
18. Participants who do not meet eligibility requirements or who have entered through fraudulent means or have provided false or misleading information will be disqualified. WCLC will not be responsible for failed entry attempts, technical malfunctions or computer or other errors for any reason whatsoever.
