Conditions:**

1. RULES AND REGULATIONS

Lotto Max™ is governed by the *Rules and Regulations Respecting Lotteries and Lottery Tickets* of Interprovincial Lottery Corporation ("ILC") which are available upon request and WHICH INCLUDE LIMITATIONS OF LIABILITY.

2. PLAY

Each play is comprised of 4 selections of 7 numbers from 1 to 52, inclusive.

3. ISSUANCE OF TICKETS

To participate, any eligible person must make valid Lotto Max selections (which can be chosen by the eligible person, computer generated, or made through a combination of both, as applicable), and pay \$6 for each play per draw or remit a winning ticket entitling such eligible person to a free play. Once an eligible person has participated, a ticket will be issued showing the draw date(s), the 4 selections for each play, the amount wagered or "FREE PLAY" in the case of a free play (which is deemed to be a \$6 amount wagered), the control number(s) and other relevant information.

4. MAIN DRAW

On each draw date, or as soon as possible thereafter, ILC will cause seven main numbers and one bonus number (being eight different numbers) to be drawn at random from among all

numbers from 1 to 52 (the "Main Draw").

5. WINNING SELECTIONS

Winning selections as a result of any Main Draw are determined as follows:

<u>WINNING SELECTION</u>	<u>CONSISTS OF</u>
7/7	the seven main numbers
6/7+	any six main numbers and the bonus number
6/7	any six main numbers and one other number*
5/7+	any five main numbers, the bonus number and one other number*
5/7	any five main numbers and two other numbers*
4/7+	any four main numbers, the bonus number and two other numbers*
4/7	any four main numbers and three other numbers*
3/7+	any three main numbers, the bonus number and three other numbers*
3/7	any three main numbers and four other numbers*

* "other number" means any number which has not been drawn.

6. WINNING TICKETS

Any valid ticket for any Main Draw bearing any winning selection of such draw is a winning ticket and entitles its holder(s) to claim, for each such winning selection, a prize calculated in accordance with Section 7 hereof.

7. MAIN DRAW PRIZES

The amount of the Main Draw 7/7 winning selection category pool for that draw (the "Main Jackpot") will be set by ILC at its discretion and be made public before the Main Draw.

After each Main Draw, ILC allocates for the payment of prizes \$2.88 for every play recorded on

the computer system of any of its Regional Marketing Organizations for that draw to prize funds as follows:

- (A) \$1.69 is allocated to the "Draw Fund" to fund the payment of (i) the Main Jackpot prize; (ii) the MAXPLUS Prizes; (iii) the MAXMILLIONS Prizes; and (iv) any additional special draw prizes which ILC may at its discretion offer from time to time.
- (B) \$1.19 is allocated to the "Prize Fund", and a "Pools Fund" is determined by deducting from the Prize Fund an amount equal to the total amount payable as prizes on the 4/7, 3/7+ and 3/7 winning selections. The amount deemed payable as a prize on each 3/7 winning selection (free play) is \$2.88.

Subject to Sections 10 and 11, prizes arising from the Main Draw are determined as follows:

¹ If there was no winning selection in any one or more of the 7/7, 6/7+, 6/7, 5/7+, 5/7 or 4/7+ categories, the amount of the prize or the pool, as applicable, for each of those said categories for which there was no winning selection for that draw will be allocated to the Draw Fund to fund prizes of subsequent draws, at ILC's discretion, provided that such allocation shall not include any amount which ILC may have undertaken to add to the Draw Fund to reach the amount of the Main Jackpot it had set as the amount of the Main Jackpot of such last preceding Main Draw.

² "Share of Main Jackpot" means an amount calculated by dividing the dollar amount of the Main Jackpot by the number of winning selections in the 7/7 category.

³ "Share of Pool" means, with reference to winning selections in each of the 6/7+, 6/7, 5/7+, 5/7, and 4/7+ categories, an amount calculated by dividing the dollar amount of the Pool, for that category, by the number of winning selections in that category.

⁴ A free play ticket is subject to the Game Conditions in effect on the draw date for which the free play ticket is issued.

8. THE MAXPLUS™ SERIES

For the purposes hereof, a "tranche" means the number of times \$1,000,000 occurs within the Main Jackpot (i.e. the amount of the Main Jackpot divided by \$1,000,000). ILC will cause, immediately after the Main Draw, as many series of seven numbers (being seven different numbers) to be drawn at random from among all numbers from 1 to 52 (each such series of seven numbers is a "MAXPLUS Series") as there are tranches of \$1,000,000 in the Main Jackpot (the "MAXPLUS Draws"). ILC has discretion to cause additional MAXPLUS Series to be drawn. Each prize offered as part of the MAXPLUS Draws is referred to as a "MAXPLUS Prize". ILC will publicly announce the number of MAXPLUS Prizes that will be offered before the applicable draw date.

On draw dates specified by ILC, and at its sole discretion, ILC may increase the prize amount for all available MAXPLUS Prizes awarded through the MAXPLUS Draws. For clarity, each MAXPLUS Prize will be at least \$100,000, and where ILC increases the minimum prize amount for MAXPLUS Draws, the prize amount will be the same for all MAXPLUS Draws for that draw date. Any such MAXPLUS Prize increase shall be announced by ILC in advance of the applicable draw date. For the avoidance of doubt, each such prize shall continue to be referred to as a "MAXPLUS Prize" for the purpose of these Game Conditions, notwithstanding its monetary value.

Subject to Sections 10 and 11, any valid ticket for that draw which bears any MAXPLUS Series of such draw is a winning ticket and entitles its holder(s) to claim, for each such MAXPLUS Series, a prize in an amount calculated by dividing the monetary value of a MAXPLUS Prize for that draw by the number of times such MAXPLUS Series appears on winning tickets.

The MAXPLUS Prizes will be funded out of the Draw Fund. Subject to the following, ILC will provide the additional funding required to satisfy the number of MAXPLUS Prizes it has set where the amount of the MAXPLUS Prizes is in excess of the Draw Fund for that draw (the "ILC MAXPLUS Funding"). The MAXPLUS Prizes which are won will be funded by the Draw Fund prior to utilizing

funding from the ILC MAXPLUS Funding. If, in such draw, there is no winning ticket bearing a MAXPLUS Series, the amount of the prize for each such MAXPLUS Series will be allocated to the Draw Fund to fund prizes of subsequent draws, at ILC's discretion, provided that only such MAXPLUS Prizes funded solely by the amount of the Draw Fund for that draw will be included in such allocation and such allocation shall not include any ILC MAXPLUS Funding.

9. THE MAXMILLIONS™ SERIES

When the amount of the Main Jackpot for any given draw would otherwise equal or exceed \$50,000,000, ILC will set in its sole discretion a number of MAXMILLIONS™ prizes for that draw (each a "MAXMILLIONS Prize"). ILC will publicly announce the number of MAXMILLIONS Prizes that will be offered before the applicable draw date.

ILC will cause, immediately after the MAXPLUS Draws, as many series of seven numbers (being seven different numbers) to be drawn at random from among all numbers from 1 to 52 (each such series of seven numbers is a "MAXMILLIONS Series") as the number of MAXMILLIONS Prizes publicly announced for that draw (the "MAXMILLIONS Draws").

Subject to Sections 10 and 11, any valid ticket for that draw which bears any MAXMILLIONS Series of such draw is a winning ticket and entitles its holder(s) to claim, for each such MAXMILLIONS Series, a prize in an amount calculated by dividing \$1,000,000 by the number of times such MAXMILLIONS Series appears on winning tickets.

The MAXMILLIONS Prizes will be funded out of the Draw Fund. Subject to the following, ILC will provide the additional funding required to satisfy the number of MAXMILLIONS Prizes it has set where the amount of the MAXMILLIONS Prizes is in excess of the Draw Fund for that draw (the "ILC MAXMILLIONS Funding"). The MAXMILLIONS Prizes which are won will be funded by the Draw Fund prior to utilizing funding from the ILC MAXMILLIONS Funding. If, in such draw, there is no winning ticket bearing a MAXMILLIONS Series, the amount of the prize for each such

MAXMILLIONS Series will be allocated to the Draw Fund to fund prizes of subsequent draws, at ILC's discretion, provided that only such MAXMILLIONS Prizes funded solely by the amount of the Draw Fund for that draw will be included in such allocation and such allocation shall not include any ILC MAXMILLIONS Funding.

For greater certainty and without limiting the generality of Sections 8 and 9, the following examples are offered to illustrate the foregoing:

Example 1: ILC decides to set the amount of the Main Jackpot at \$50,000,000, ILC has set a number of 50 MAXPLUS Prizes at \$100,000 and 2 MAXMILLIONS Prizes, the amount of the Draw Fund reaches \$48,500,000, and there is no winning selection in the 7/7 category of the Main Draw:

- If 15 MAXPLUS Prizes and 2 MAXMILLIONS Prizes are won:
 - The \$1,500,000 for the MAXPLUS Prizes will be funded by the Draw Fund;
 - The \$2,000,000 for the MAXMILLIONS Prizes will be funded by the Draw Fund; and
 - \$45,000,000 will be allocated to the Draw Fund to fund prizes of subsequent draws.

Example 2: ILC decides to set the amount of the Main Jackpot at \$55,000,000, ILC has set a number of 55 MAXPLUS Prizes at \$100,000 and 4 MAXMILLIONS Prizes, the amount of the Draw Fund reaches \$58,800,000, and there is at least one winning selection in the 7/7 category of the Main Draw:

- If 14 MAXPLUS Prizes and 2 MAXMILLIONS Prizes are won:
 - The \$55,000,000 Main Jackpot will be funded by the Draw Fund;
 - The \$1,400,000 for the MAXPLUS Prizes will be funded by the Draw Fund;
 - The \$2,000,000 for the MAXMILLIONS Prizes will be funded by the Draw Fund; and
 - \$400,000 will be allocated to the Draw Fund to fund prizes of subsequent draws.
- If 20 MAXPLUS Prizes and 3 MAXMILLIONS Prizes are won:
 - The \$55,000,000 Main Jackpot will be funded by the Draw Fund;
 - The \$2,000,000 for the MAXPLUS Prizes will be funded by the Draw Fund;
 - The \$3,000,000 for the MAXMILLIONS Prizes will first be funded by the remaining \$1,800,000 in the Draw Fund and the ILC MAXMILLIONS Funding will be \$1,200,000; and
 - No amount will be allocated to the Draw Fund to fund prizes of subsequent draws.

10. PRIZE CALCULATION - ROUNDING

For the 7/7, 6/7+, 6/7, 5/7+, 5/7 and 4/7+ categories, the MAXPLUS Prizes, and the MAXMILLIONS Prizes, the amount of each prize is calculated by dividing the dollar amount of that category's pool or, in the case of the MAXPLUS Prizes, the monetary value of a MAXPLUS Prize in accordance with Section 8, and in the case of MAXMILLIONS Prizes, \$1,000,000, by the number of winning selections in that category provided that:

- (A) for the Main Jackpot, MAXPLUS Prizes, and MAXMILLIONS Prizes, cents are increased to the next \$0.10 (e.g. \$8,075,487.12 is rounded up to \$8,075,487.20), and
- (B) for 6/7+, 6/7, 5/7+, 5/7 and 4/7+ prizes, cents under \$0.05 are reduced to \$0.00 (e.g. \$2,726.34 is rounded down to \$2,726.30) and cents \$0.05 and over are increased to \$0.10 (e.g. \$2,726.35 is rounded up to \$2,726.40).

For the 4/7, 3/7+ and 3/7 categories, the prizes are fixed as set out in Section 7.

11. PRIZE CLAIMS

Prizes must be claimed within one year following the draw date.

12. ODDS OF WINNING

The approximate odds of winning in the Main Draw are set out as follows:

The approximate odds of winning in any MAXPLUS Draw or MAXMILLIONS Draw are the same as the odds of winning 7/7 in the Main Draw.
