PICK 4 GAME CONDITIONS AND PRIZE STRUCTURE STATEMENT

## 1. RULES AND REGULATIONS

PICK 4 is governed by the Rules and Regulations Respecting Lotteries and Gaming of Western Canada Lottery Corporation (WCLC) WHICH INCLUDE LIMITATIONS OF LIABILITY AND ARE AVAILABLE FROM WCLC UPON REQUEST.

## 2. ISSUANCE OF TICKETS

To participate, a person must present a completed PICK 4 selection slip or request a Quick Pick ticket (where all selections are computer generated) and pay the authorized retailer $\$ 1$ for each PICK 4 selection, per draw. A ticket will be issued showing the draw date(s), the selection(s), the type of play (straight or box play), a control number(s) and other relevant information. 1, 2, 5, 10 and 25 consecutive draws can be played per selection slip by marking the appropriate number in the \# Draws box and paying the appropriate amount.
A selection with the same 4 digits (e.g. 4444) is eligible for straight play only. For Box Play, the digits selected determine which Box Play category the ticket is eligible for, and is a:
(a) "4-Way Box Play", if the digits selected are three identical digits and one unique digit (e.g. 1000, 2232, 8886);
(b) "6-Way Box Play", if the digits selected are two sets of identical digits (e.g. 0011, 3773, 5454);
(c) "12-Way Box Play", if the digits selected are two identical digits and two unique digits (e.g. 0021, 3453, 6604);
(d) "24-Way Box Play", if the digits selected are four unique digits (e.g. 1234, 5079, 9638).

WCLC may, at all times and at its discretion, refuse to issue tickets bearing any selection, as WCLC determines.

## 3. DRAW

On each draw date, WCLC will cause one 4-digit number to be drawn at random from among all numbers in a field from 0000 to 9999.

## 4. WINNING SELECTIONS

Winning Selections in any draw consist of the following:
WINNING SELECTION CONSISTS OF
Straight Play An exact match of the four digit number drawn;
Box Play A match of all four digits of the four digit number drawn, in any order.

## 5. WINNING TICKETS

Any valid ticket for any draw bearing any Winning Selection of such draw is a Winning Ticket and entitles its holder(s) to claim, for each such Winning Selection, a prize calculated in accordance with Section 7 hereof. Only one prize per Winning Selection may be claimed.

## 6. ADVANCE PLAY

If a ticket becomes a Winning Ticket and is eligible for additional draws following the draw date for which it is produced to win a prize, the prize will be paid and a substitute or replacement ticket will be issued for the remaining outstanding draw dates for which it is eligible and the ticket originally produced will, upon issuance of such substitute or replacement ticket, become void.

## 7. PRIZES

| 4-Way Box (any order) | $\$ 1,250$ |
| 6-Way Box (any order) | $\$ 800$ |
| 12-Way Box (any order) | $\$ 400$ |
| 24-Way Box (any order) | $\$ 200$ |

## 8. PRIZE CLAIMS

Prizes must be claimed in the manner stated on the back of the ticket within one year following each draw date for which the ticket is eligible to win a prize.
